"All that certain piece<sup>s</sup>/parcel<sup>s</sup>/or lot<sup>s</sup> of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the Western side of Brookway Drive, near the City of Greenville being lots 21, 22 and one-half of lot 23 of Block E as shown on plat of Grove Park, made by W. J. Riddle in April 1939, recorded in Plat Book J at Page 69, and described as follows:

BEGINNING at a stake on the Western side of Brookway Drive at corner of lot 20 and running thence with line of said lot, S. 61 W. 256 feet to a stake on a branch; thence with said branch in a northerly direction 84.5 feet to a stake in the center of lot 23; thence N. 66 E. 261 feet, more or less, to a stake on Brookway Drive; thence with the Western side of Brookway Drive, S. 14-57 E. 31.1 feet to a stake; thence continuing with the western side of Brookway Drive, S. 17-07 E. 32.4 feet to the beginning corner.
