"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the Southern side of Marion Road (Formerly known as Nichols Street) near the City of Greenville, and being a portion of Lot 15, as shown on plat of City View Annex, recorded in Plat Book H at Page 80, and described as follows:

BEGINNING at a stake on the Southern side of Marion Road, at corner of lot 16, and running thence with line of said lot, S. 24-50 E. 275.2 feet to stake; thence N. 60-15 E. 50.2 feet to stake, corner of property of Ralph J. Campbell; thence with line of said lot, N. 24-50 W. 270.5 feet to stake on Marion Road; thence with Southern side of Marion Road, S. 65-10 W. 50 feet to the beginning corner; being the same premises conveyed to the mortgagor herein by H.
