"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, known and designated as lot 83 of Anderson Street Highlands on plat recorded in Plat Book J at Page 157 and having, according to said plat, the following metes and bounds, to-wit:-

BEGINNING at an iron pin on the South side of Somerset Avenue (Formerly East King Street) 205 feet East of the Southeastern intersection of East King Street and Hodges Street and running thence with Somerset Avenue, S. 47-20 E. 75 feet to an iron pin, joint corner of lots 83 and 84; thence along the line of lot 84, S. 42-40 W. 129 feet to an iron pin; thence N. 47-20 W. 75 feet to an iron pin, corner of lot 82; thence with line of said lot, N.42-40 E 129 feet to the beginning corner.
