new Super Highway N. 29 to Hillcrest Drive and being shown and designated as a part of lot #4
on plat of property of I. B. Brannon prepared by J. Earle Freeman, Surveyor, October 5th 1927, and
being a part of the same land conveyed to me by deed from J. R. George, June 8th 1929, and record-
