MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, John P. Batson

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

Three Thousand and No/100 - - - - -

DOLLARS (\$ 3,000.00), with interest thereon from date at the rate of five & one-half per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the Western side of Rutherford Street in the City of Greenville, being shown as Lot No. 6 of Block 2, Page 20, of the City Block Book, and described as follows:-

"BEGINNING at a stake on the Western side of Rutherford Street, 50 feet South from Goodwin Street, corner of Lot No. 7, and running thence with the line of said lot, S. 69-30 W. 108.6 feet to a stake in line of Lot No. 8; thence with the line of said lot, S. 3-30 E. 50 feet to a stake in line of Lot No. 5; thence with the line of said lot, N. 69-30 E. 105 feet to Rutherford Street; thence with the Western side of Rutherford Street, N. 100 W. 50 feet to the beginning corner."

Included within the above boundaries is a 12-foot alley extending from Goodwin Street along the rear line of the above lot.
