BEGINNING at an iron pin on the South side of Spring Street at the N.E. corner of Lot No. 80 and runs thence S. 13 E. 170.2 feet along the line of lot No. 80 to a stake on the Smith line; thence S. 77 W. 50 feet along Smith line to a stake at the corner of lot No. 82; thence N. 13 W. 170.7 feet along line of lot No. 82 to a stake on Spring Street; thence N. 77 E. 50 feet along the said Spring Street to the beginning corner, and being lot No. 81 of the N.M.
