TO ALL WHOM THESE PRESENTS MAY CONCERN: We, Thad W. Riddle and Lula Mae Riddle

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Ninety-Five Hundred and No/100 - - - - - DOLLARS (\$ 9500.00), with interest thereon from date at the rate of Five & one-half per centum per annum, said principal and interest to be repaid as therein stated, and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, and being known and designated as Lot No. 101 as shown on a preliminary plat made by Dalton and Neves in April 1940, and is also shown on plat of Forest Heights, recorded in the Office of R.M.C. for Greenville County in Plat Book "P" at Page 71, and being more particularly described, according to said plat, as follows:

\*BEGINNING at an iron pin on the Southern side of East Paris Road, joint front corner of Lots Nos. 100 and 101, and running thence along said East Paris Road, N. 64-30 E. 77 feet to an iron pin, corner of Lot No. 102; thence S. 24-40E. 160 feet to an iron pin; thence S. 64-30 W. 77 feet to an iron pin; thence N. 24-40W. 160 feet to the beginning corner.
