"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Butler Township, being known and designated as lot #7 of Block H as shown on a plat of Fair Heights, recorded in Plat Book "F" at Page 257, and more particularly described, according to said plat, as follows:-

"BEGINNING at an iron pin on Brookdale Avenue, joint front corner of lots #6 and 7 and running thence with joint line of said lots N. 58-40 W. 150 feet to an iron pin in rear line of lot #18; thence with lot #18, S. 31-20 W. 50 feet to an iron pin, joint rear corner of lots #7 and 8; thence with joint line of said lots, S. 58-40 E. 150 feet to an iron pin on Brookdale Avenue; thence with Brookdale Avenue, N. 31-20 E. 50 feet to the beginning corner.
