MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, Irene New Brower
..... (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Five Hundred Fifty and No/100 - - - -

DOLLARS (\$550.00.....), with interest thereon from date at the rate of Six (6%)..... per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, about two miles north of the City of Greenville, same being a portion of a subdivision known as Newland, and designated as lot No. 43, Block 1, recorded in Plat Book C, Page 199, and described as follows:

"BEGINNING at a stake 180 feet from Newland Avenue, and running thence with Charles Street N. 43-12 E. 50 feet to stake, corner of lots Nos. 42 and 43; thence N. 46-48 W. 150 feet to stake corner of lots Nos. 42 and 43; thence with line of alley, S. 43-12 W. 50 feet to corner of lots 43 and 44; thence S. 46-48 E. 150 feet to beginning corner."

Said premises being the same conveyed to the mortgagor by Charles A. New by deed dated October 7, 1939, recorded in Book of Deeds 220; at Page 341.
