TO ALL WHOM THESE PRESENTS MAY CONCERN:----- I, Nelle C. Wilbanks

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of-----

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, on the Southern side of Russell Avenue, and being known and designated as lot No. T-15 as shown on plat of the property of G. H. Talley, recorded in the Office of R.M.C. for Greenville County in Plat Book "H" at Page 116, and being more particularly described, according to said plat, as follows:

"BEGINNING at an iron pin on the Southern side of Russell Avenue, joint front corner of lots Nos. T-14 and T-15, which point is 250 feet East on intersection of Russell Avenue and Bennett Street, and running thence S. 19-21 W. 114 feet to an iron pin; thence S. 70-30 E. 48.5 feet to an iron pin; thence N. 19-21 E. 114 feet to an iron pin on the Southern side of Russell Avenue; thence with Russell Avenue, N. 70-30 W. 48.1 feet to the beginning corner."

Said premises being the same inherited by the mortgagor and June Wilbanks Rumler from C. L. Wilbanks, as will more fully appear by reference to Apartment 507, File 13, in the office of the Probate Judge for Greenville County; the interest of the said June Wilbanks Rumler having been conveyed to the mortgagor by deed dated January 6, 1947, recorded in Volume 306 at Page 104.
