NOW, KNOW ALL MEN, that Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described property situated in the county of Greenville, Greenville Township, State of South Carolina; on the Northeast side of Mary Street

and designated as Lot #67 of Map 1 of Camilla Park, a Plat of which is recorded in the R.M.C. Office for Greenville County in Plat Book G at Page 225, and having, according to said Plat, the following metes and bounds, courses and distances, to-wit:-

BEGINNING at an iron pin on the Northeast side of Mary Street, which iron is 204 feet in a Northwesterly direction from the Northeastern intersection of Frances Avenue and Mary Street, joint corner of Lots Nos. 66 and 67, thence along the joint line of said lots, N. 67-54 E. 191.9 feet to an iron pin in the line of a 20-foot alley; thence along the Southwestern side of said alley, N. 18-32 W. 67.95 feet to an iron pin, rear joint corner of Lots Nos. 67 and 68; thence along the joint line of said lots, S. 67-56 W. 194.6 feet to an iron pin in the line of Mary Street; thence along the Northeastern side of Mary Street, S. 20-45 E. 68 feet to the point of beginning.
