TO ALL WHOM THESE PRESENTS MAY CONCERN: Maud Threadway

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. "All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the West side of 8th Avenue in Judson Mills Village No. 2, being known and designated as lot No. 12 of Block D, as shown on plat of Judson Mills Village No. 2 recorded in Plat Book "K" at pages 1 and 2, and having according to said plat the following metes and bounds, to-wit:-

~~BEGINNING at an iron pipe on the western side of 8th Avenue, joint corner of Lots 11 and 12 which pipe is 170.1 feet northwest of the Northwest corner of the intersection of 8th Avenue and Gordon Street, and running thence with 8th Avenue N. 39-30 W. 80 feet to an iron pipe, corner lots 12 and 13; thence with the line of lot No. 13 S. 53-11 W. 133.2 feet to an iron pipe, joint corner of lots 5, 6, 12, and 13; thence with the line of lot No. 6 S. 18-40 E. 82.1 feet to iron pipe in rear line of lot No. 8; thence with the rear line of lots 8, 9, 10 and 11 N. 53-51 E. 162.6 feet to the point of beginning.~~
