

MORTGAGE OF REAL ESTATE-G.R.E.M. 9

WE, G. L. CHILES AND LILLA L. CHILES

SEND GREETING:

WHEREAS, we the said G. L. Chiles and Lilla L. Chiles

in and by OUR certain promissory note in writing, of even date with these presents are well and truly indebted to LIBERTY LIFE INSURANCE COMPANY, a corporation chartered under the laws of the State of South Carolina, in the full and just sum of Seven Thousand Nine Hundred - - - - (\$7,900.00) DOLLARS, to be paid at its Home Office in Greenville, S. C., together with interest thereon from date hereof until maturity at the rate of five (5 %) per centum per annum, said principal and interest being payable in monthly installments as follows:

Beginning on the 11th day of August, 1947, and on the 11th day of each month of each year thereafter the sum of \$ 83.82, to be applied on the interest and principal of said note, said payments to continue up to including the 11th day of June, 1957, and the balance of said principal and interest to be due and payable on the 11th day of July, 1957; the aforesaid monthly payments of \$ 83.82 each are to be applied first to interest at the rate of five (5 %) per centum per annum on the principal sum of \$ 7,900.00 or so much thereof as shall, from time to time, remain unpaid and the balance of each monthly payment shall be applied on account of principal.

All installments of principal and all interest are payable in lawful money of the United States of America; and in the event default is made in the payment of any installment or installments, or any part thereof, as therein provided, the same shall bear simple interest from the date of such default until paid at the rate of seven (7%) per centum per annum.

And if any portion of principal or interest be at any time past due and unpaid, or if default be made in respect to any condition, agreement or covenant contained herein, then the whole amount evidenced by said note to become immediately due, at the option of the holder thereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity should be placed in the hands of an attorney for suit or collection, or if before its maturity, it should be deemed by the holder thereof necessary for the protection of its interests to place, and the holder should place, the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including ten (10%) per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

NOW, KNOW ALL MEN, That we, the said G. L. Chiles and Lilla L. Chiles in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said LIBERTY LIFE INSURANCE COMPANY according to the terms of the said note, and also in consideration of the further sum of THREE DOLLARS, to us the said G. L. Chiles and Lilla L. Chiles in hand well and truly paid by the said LIBERTY LIFE INSURANCE COMPANY, at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said LIBERTY LIFE INSURANCE COMPANY.

All that certain piece, parcel or lot of land with the buildings and improvements thereon situate, lying and being on the West side of East North Street, in Ward 2 of the City of Greenville, County of Greenville, State of South Carolina, being shown as Lot 2 on Plat of property of Annie Griffin et al, made by Dalton & Neves, Engineers, January 1929, recorded in the R.M.C. Office for Greenville County, S.C. in Plat Book "H", Pages 178 and 179, and having, according to said Plat, the following metes and bounds, to-wit:-

BEGINNING at an iron pin on the West side of East North Street at joint front corner of Lot 1 and 2, said pin being 70.7 feet North from the Northwest corner of the intersection of East North Street and Richland Avenue, and running thence with the line of Lot 1, N. 77-03 W. 180.8 feet to an iron pin in line of lot 25; thence with the line of Lot 25, N. 20-41 E. 70.3 feet to a iron pin; thence with the line of Lot 3, S. 77-03 E. 163.4 feet to an iron pin on the West side of East North Street; thence with the West side of East North Street, S. 6-24 W. 70 feet to the beginning corner.

This is the same property conveyed to us by deed of M. T. Batson, dated August 24, 1942, recorded in the R.M.C. Office for Greenville County, S.C. in Deed Book 247, Page 22.
