MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, Mary Lora Fletcher
(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Nine Hundred and No/100

DOLLARS (\$ 900.00), with interest thereon from date at the rate of Six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, being known and designated as lot #22 as shown on plat of property of Junction Heights recorded in Plat Book C at Page 106 and being more particularly described as follows:

"BEGINNING at an iron pin on the North side of Reedy Street, joint front corner of lots 21 and 22 and running thence with joint line of said lots, N. 37-06 W. 150 feet to an iron pin in line of lot #29; thence with line of lot #29, S. 62-30 W. 50 feet to an iron pin in line of lot #25; thence with line of lots #25, 24 and 23, S. 37-06 E. 150 feet to iron pin on Reedy Street; thence with Reedy Street, N. 62-30 E. 50 feet to the beginning corner. Being the same premises conveyed to the mortgagor herein by Louie E. Smith by deed dated 10th September, 1942, recorded in Volume 247, at Page 194."
