WHEREAS: Bill Ashley Jordan of near Greenville, South Carolina, hereinafter called the Mortgagor, is indebted to Carolina Housing and Mortgage Corporation

organized and existing under the laws of the State of Delaware, hereinafter called Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Six Thousand and no/100 - - - - Dollars (\$ 6,000.00 ),

with interest from date at the rate of four per centum ( 4 %) per annum until paid, said principal and interest being payable at the office of Carolina Housing and Mortgage Corporation

in Hickory, North Carolina, or at such other place as the holder of the note may designate in writing delivered or mailed to the Mortgagor, in monthly installments of Thirty-two and 45/100 - - - - Dollars (\$ 32.45 ),

commencing on the first day of October, 19 47, and continuing on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of September, 19 71.

NOW, KNOW ALL MEN, that Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described property situated in the county of Greenville - - - - State of South Carolina;

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, lying and being situate on the Northwest side of Langley Drive, being known and designated as Lot #25, according to Plat of Langley Heights, prepared by Dalton & Neves, Engineers, recorded in the R.M.C. Office, County of Greenville, South Carolina, in Plat Book "N" on page 133, said Lot being revised as shown on revised Loan Plat prepared by R. E. Dalton, Engineer, August 1947, and having, according to said revised plat, the following metes and bounds, to-wit:-

BEGINNING at an iron pin on the Northwest side of Langley Drive, at joint front corner of Lots #25 and #26, said pin being 251.7 feet Northeast of Northeast corner of the intersection of Langley Drive with Edgewood Drive, thence N. 31-37 W. 168.3 feet to a stake at joint rear corner of Lots #25 and #26 on a 15 feet alley; thence S. 46-47 W. 51.1 feet along the South boundary of said alley to a stake at joint rear corner of Lots #24 and #25; thence S. 27-49 E. 118.9 feet to a stake; thence S. 43-34 E. 40.1 feet to an iron pin on the Northwest side of Langley Drive at joint front corner of Lots #24 and #25; thence N. 58-23 E. 50 feet along said Drive to an iron pin at joint front corner of Lots #25 and #26, the point of beginning.
