AGREEMENT FOR EXTENSION OF LOAN.

WHEREAS, there remains unpaid on a certain note and mortgage given by Grace Andrews to Liberty Life Insurance Company dated August 1, 1945 covering property in the City of Greenville South Carolina, said mortgage being of record in the R.M.C. Office for Greenville County, S. C. in Mortgage Book 336, page 172, the sum of Eleven Thousand, Six Hundred & No/100 (\$11,600.00) Dollars with interest thereon from August 1st 1947, and,

WHEREAS, Grace Andrews is still the owner of the premises covered by the above mentioned mortgage, and,

WHEREAS, the said Grace Andrews has requested that Liberty Life Insurance Company extend the time of payment of said note as hereinafter provided, which said Liberty Life Insurance Company has consented and agreed to do,

NOW, THEREFORE, in consideration of the premises, I, Grace Andrews do hereby agree to pay Liberty Life Insurance Company the sum of Eleven Thousand, Six Hundred & No/100 (\$11,600.00) Dollars, that being the balance due on the note above mentioned with interest thereon from August 1st, 1947, at the rate of five (5%) per cent per annum, said principal and interest to be paid in monthly installments, as follows:

BEGINNING on the 1st day of September 1947, and on the 1st day of each month of each year thereafter the sum of \$81.75, to be applied on the interest and principal of said note, said payments to continue up to and including the 1st day of July 1962, and the balance of the said principal and interest to be due and payable on the 1st day of August 1962; the aforesaid monthly payments of \$81.75 each are to be applied first to interest at the rate of five (5%) per centum per annum on the principal amount of \$11,600.00, or so much thereof as shall from time to time remain unpaid, and the balance of each monthly payment shall be applied on account of principal.

IT IS FURTHER AGREED that all other terms, stipulations and conditions contained in the said note and mortgage shall remain as written except as herein modified.

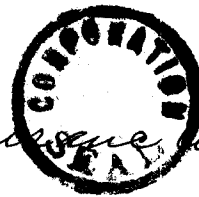
