TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, William C. Miller, of Greenville County - - -

SEND GREETINGS:

WHEREAS I, the said

William C. Miller

in and by my certain promissory note, in writing, of even date with these presents am well and truly indebted to

FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, in the full and just sum of FOUR THOUSAND, FIVE HUNDRED AND NO/100

(\$4,500.00) Dollars, with interest at the rate of six (6%) per centum per annum, to be repaid in instalments of THIRTY-FIVE AND NO/100

(\$ 35.00) Dollars upon the first

day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee besides all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW, KNOW ALL MEN, That I, the said William C. Miller

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., according to the terms of said note, and also in consideration of the further sum of Three Dollars to me

the said William C. Miller

in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., the following described property to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and in Greenville Township, and being made up of a portion of Lot No. 43 and a portion of Lot No. 44, of a subdivision known as Augusta Road Hills, as shown on plat thereof recorded in the R.M.C. Office for Greenville County in Plat Book L, at pages 56 and 57, and having the following metes and bounds, to-wit:-

"BEGINNING at an iron pin on the southeast side of Cammer Avenue in the front line of Lot No. 44, which point is 126.4 feet from the curvature of the intersection of Low Hill street with said Cammer Avenue, and is also 15 feet southwest of the corner of Lot No. 45, and running thence on a line through Lot No. 44 and parallel with the line of Lot No. 45, S. 47-50 E. 165 feet to an iron pin at a point 15 feet southwest of the rear corner of Lot No. 45; thence S. 42-10 W. 75 feet to an iron pin in the rear line of Lot No. 43, which point is 30 feet southwest of the rear corner of Lot No. 44; thence on a line through the center of Lot No. 43, N. 47-50 W. 165 feet to an iron pin in the center of the front line of said Lot No. 43, which point is 30 feet northeast of the corner of Lot No. 42; thence along the southeast side of Cammer Avenue, N. 42-10 E. 75 feet to the beginning corner." Being the same lot conveyed to me by J. E. Heatherly by deed of even date herewith, not yet recorded.
