MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, M. L. Ledford
.....(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. "All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville at the Southeastern intersection of Anderson Street and Arlington Avenue, and being more particularly described as follows:

"BEGINNING at an iron pin on the Southeastern corner of Anderson Street and Arlington Avenue (formerly Garlington Street), and running thence with Arlington Avenue, S. 72 E. 90 feet, more or less, to a stake; thence S. 23 1/2 W. 69.7 feet to a stake; thence N. 72 W. 99.6 feet, more or less, to an iron pin on Anderson Street; thence with Anderson Street, N. 30-55 E. 71.5 feet to the beginning corner."
