BEGINNING at an iron pin at the southwest corner of Foister Street and Furman Hall Road,  
and running thence in a southerly direction 50 feet along Furman Hall Road to iron pin, joint  
corner said lot and Mathews lot; thence along Mathews line in an easterly direction 200 feet to  
iron pin, joint corner of A. J. Lister, Mathews and said lot; thence in a northerly direction  
50 feet to iron pin on Foister Street; thence along Foister Street in a westerly direction 200  
feet to Furman Hall Road and the beginning corner, being the same conveyed to the mortgagor herein  
by E. B. Foister by deed dated March 17, 1938, recorded in Book 212, page 324.

Also, that lot of land in Greenville Township, Greenville County, South Carolina, near
