"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, being known and designated as lot #12 of Block F of Judson Mills Village #2 as shown on plat thereof recorded in Plat Book K at Pages 1 and 2, and having, according to said plat, the following metes and bounds, to-wit:-

BEGINNING at an iron pin on the West side of Eighth Avenue, joint corner of lots Nos. 12 and 13, which iron pin is 205.1 feet South of the Southwest corner of the intersection of Eighth Avenue and an unnamed street, and running thence with line of lot #13, S. 81-09 W. 133.4 feet to an iron pin in rear line of lot #3; thence with rear line of lots #3 and 4, S. 8-43 E. 50 feet to an iron pipe, joint rear corner of lots #11 and 12; thence with line of lot #11, N. 81-09 E. 133.5 feet to an iron pin on the West side of Eighth Avenue; thence with Eighth Avenue, N. 8-57 W. 50 feet to the beginning corner; and being the same premises conveyed to the mortgagor herein by Wade H.
