MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, Minnie White

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. "All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the ~~East~~ side of Green Avenue, between Garlington and St. John Streets, in the City of Greenville, and described as follows:

"BEGINNING at an iron pin on Green Avenue, thence with said Avenue, S. 27 W. 67 feet to a corner of the Wm. Bowen lot; thence with the line of that lot S. 72 E. 150 feet to a post; thence N. 27-30 E. 65-1/3 feet to a post; thence N. 27 W. 150 feet to the beginning corner."
