TO ALL WHOM THESE PRESENTS MAY CONCERN: I . Mary E. Garner

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of -----
Fifteen Hundred and No/100 -----

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as Lot No. 20 on Flat of the property of W. D. McBrayer, recorded in the RMC Office for Greenville County in Plat Book "J" at Page 37, and having, according to said flat, the following metes and bounds, to-wit:-

"BEGINNING at an iron pin on the Eastern side of Washington Avenue at joint corner of Lots Nos. 20 and 21, and running thence with the joint lines of said lots, N. 41-13 E. 565.7 feet to an iron pin; thence N. 47-20 W. 100 feet to an iron pin in line of Lot No. 19; thence with the joint line of Lots Nos. 19 and 20, S. 41-13 W. 527 feet to an iron pin on the Eastern side of Washington Avenue; thence with the Eastern side of Washington Avenue, S. 26-06 E. 108 feet to the beginning corner."
