in monthly installments of Fifteen Dollars (\$15.00) payable on the 26th day of each month hereafter for the first eleven months from date, but entire balance of principal and interest due one year from date. Default in any one or more payments when due to cause entire debt at holder's option to at once become due and collectible.

with interest thereon from date hereof at the rate of 7 per centum per annum, to be computed and paid monthly from date
