TO ALL WHOM THESE PRESENTS MAY CONCERN: I, Alma S. Waldrop

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. "All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Northeast side of Edgewood Avenue, near the City of Greenville, being shown as 1 #35 on plat of Leawood, made by Dalton & Neves, June 1938, recorded in plat Book J at Pages 18 19, and described as follows:

"BEGINNING at an iron pin on the Northeast side of Edgewood Avenue, at the joint corners lots #34 and 35; thence N. 55-18 W. 77 feet to an iron pin; thence N. 33-54 E. 167.4 feet; then S. 55-41 E. 77 feet to an iron pin; thence S. 33-54 W. 167.9 feet to Edgewood Avenue, the point of beginning. Being the same premises conveyed to the mortgagor herein by deed recorded in Vol 314 at Page 309."
