MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, V. O. Boroughs, Jr.,

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Two Thousand and No/100

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Butler Township, on the Southeast side of West View Avenue, near the City of Greenville known and designated as lot #20 of Block C, Section 2, on Plat of East Highland Estates, recorded in the R.M.C. Office for Greenville County in Plat Book K at Page 44, and having, according to said plat, the following metes and bounds, to-wit:-

"BEGINNING at an iron pin on the Southeast side of West View Avenue, at joint front corner of lots 20 and 21 of Block C and running thence with line of lot #21, S. 52-50 E. 165 feet to an iron pin on the Northwest side of a 5 foot strip reserved for utilities; thence along Northwest side of said strip, S. 39-23 W. 60.05 feet to an iron pin, corner of lot #19; thence with line of lot #19, N. 52-50 W. 162.5 feet to an iron pin on the Southeast side of West View Avenue; thence along Southeast side of West View Avenue, N. 37-0 E. 60 feet to the point of beginning. Being the same premises conveyed to the mortgagor herein by deed recorded in Book of Deeds 306 at Page 16."
