"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, on the North side of East Washington Road, and being known and designated as lot #85, of Block E, of the Subdivision known as East Park, beign a portion of Boyce Addition, as shown by plat recorded in Plat Book A, at Page 383, and being more particularly described as follows:
