NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the South side of Hudson Street, near the Buncombe Road, and being known and designated as lot No. 1 as shown on Plat of the Property of J. B. Ballenger, recorded in Plat Book D, at Page 119, and being more particularly described according to said plat as follows:

"BEGINNING at an iron pin at the Southwest intersection of Hudson Street and Williams Street and running thence with Williams Street, S. 21-20 E. 140 feet to an iron pin; thence N. 54 1/2 E. 52 1/2 feet to an iron pin in line of lot No. 2; thence with the line of said lot, N. 21-20 W. 140 feet to an iron pin in the South side of Hudson Street; thence with the South side of Hudson Street ^{54 1/2} S. 54 1/2 feet to the beginning corner.
