BEGINNING at a stake on the Western side of Hunt's Bridge Road, corner of Lands of J. K. Keller, and running thence with said Road S. 1-51 W. 70 feet to a stake where the Western line of the White Horse Road intersects the Western line of said Hunt's Bridge Road; thence with the White Horse Road S. 17-36 W. 302 feet to an iron pin; thence with property of James S. or Thelma E.
