Willis, and a portion of Lot No. 5 of Block H of Property of H. H. Willis, known as Woodville Heights as shown on plat thereof made by W. J. Riddle, dated December 1940, recorded in the R. M. C. Office for Greenville County, in Plat Book L, pages 14 and 15 (another plat thereof being recorded in Plat Book K, pages 272-275) and having according to said plats the following metes and bounds, to-wit:
