until paid; interest to be computed and paid - - - - - annually, and if unpaid when due to
bear interest at same rate as principal until paid, and we have further promised and agreed to pay ten per
cent of the whole amount due for attorney's fee, if said note be collected by attorney or through legal
proceedings of any kind, reference being thereunto had will more fully appear.

bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Lidann Bridwell- - - - - all that tract or lot of land in
Greenville- - - - - Township, Greenville County, State of South Carolina.,

about two and one-half miles from Greenville County Court House near the
road leading from the American Spinning Company to Paris Mountain and
being the Western one-half of that section lot conveyed to W.W. Jarrell
by C.E. Robinson, as Trustee, by deed dated April 18, 1944 and re-
corded in Deed Book 263, Page 32, R.M.C. Office for Greenville County
and having the following metes and bounds:

BEGINNING at a stake on the South side of Cothran Street re-
ferred to in the above mentioned deed as an unnamed street,
said stake being the original Northwest corner of the lot con-
veyed to W.W. Jarrell in deed above mentioned and running thence
S. 23½ W. 195 feet more or less to a stake original Southwest
corner of lot conveyed to W.W. Jarrell; thence S. 56½ E. 50 ft.
to a stake; thence N. 23½ E. 195 feet more or less to a stake
