All that piece, parcel or lot of land in Grove Township, Greenville County, State of South Carolina, containing one and one-fourth (1 1/4) acres, more or less, and having the following metes and bounds to wit;

BEGINNING at an iron pin in center of the Old Pelzer Road on corner of lands formerly belonging to Oscar Chapman and running thence along said road S. 40 E. 3 chains 3 links to a point in the road; thence S. 51 1/2 W. 3.47 to an angle in the road; thence S. 84 W. 1.00 to an angle in road; thence N. 60 W. 2.06 to corner of the J.
