"All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, and in Gantt Township, on the East side of National Highway No. 29, also known as the Piedmont Highway, being known and designated as a portion of Tract No. 17 of the property of E. A. Smythe, as shown on plat thereof made by Dalton & Neves, Engrs., in 1935 and recorded in the R. M. C. office for Greenville County in Plat Book D, at pages 170 and 171, and having the following metes and bounds, to-wit:
