

TRACT II

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, on the East side of Main Street in Ward 2 of the City of Greenville as follows:

BEGINNING at a stake on Main Street and running thence 213 feet on a line perpendicular to Main Street to a stake corner; thence 53 feet on a line parallel with Main Street to a stake corner; thence 213 feet on a line perpendicular to said street to a stake corner, thence 53 feet to the beginning corner. See deed recorded in the R. M. C. Office for Greenville County in Vol. RRR, page 672.

Also, the said lot adjoining above lot on the South as follows:

BEGINNING on the east side of Main Street, at corner of lot formerly owned by W. T. Bull (now Bryan's) and running thence with Bull's line S. 73 E. 3.15 chains to a stake; thence S. 19 W. 27 3/4 feet to a stake; thence N. 73 W. 3.15 Chains to Main Street; thence with Main Street N. 19 E. 27 feet to the beginning corner. All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, in Ward 1, City of Greenville, on the northwest corner of North Main Street and West Park Avenue (formerly Carrier Street) containing 44/100 of an acre, more or less, and having the following metes and bounds:

BEGINNING at an iron pin at the corner of North Main Street and Park Avenue; thence with North Main Street N. 19-3/4 E. 85 feet to an iron pin; thence N. 76-1/2 W. 231 feet to an iron pin on a 20-foot alley; thence with alley S. 13-1/2 W. 85 feet to an iron pin on Park Avenue; thence with Park Avenue, S. 76-1/2 E. 222 feet to the beginning corner.

Baumann, Julian H. Baumann and Raymon Baumann by deed dated August 25, 1943 and recorded in Deed Book Volume 256 at Pg. 201.
