All that piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina, on the North side of the Laurens Road, and being known and designated as Lot No. three (3), of the property of G. B. Lee, as shown on plat thereof, recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book K, at page 43, which plat is a re-division of Lots Nos. 1, 2, 3, 7, 8, 9, 10, and 11 of Block B, of Carolina Court, and having the following metes and bounds, to-wit;
