organized and existing under the laws of South Carolina, hereinafter called Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Seventy-Five Hundred and No/100 - - - - - Dollars (\$ 7500.00), with interest from date at the rate of Four - - - - - per centum (4 %) per annum until paid, said principal and interest being payable at the office of Fidelity Federal Savings & Loan Association in Greenville, South Carolina, or at such other place as the holder of the note may designate in writing delivered or mailed to the Mortgagor, in monthly installments of Forty-Five and No/100 - - - - - Dollars (\$ 45.45), commencing on the first day of June, 1948, and continuing on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of May, 1968.

Now, KNOW ALL MEN, that Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described property situated in the county of Greenville, State of South Carolina;

All that certain piece, parcel or lot of land in Greenville Township, about three miles Northeast of the City of Greenville, being known and designated as Lots Nos. 3, 4, 5 of Section H of the Stone Estates as shown on a plat thereof prepared by C. M. Furman, Jr. in December, 1931, recorded in the Office of R. M. C. for Greenville County in Plat Book "G" at Page 294, and being more particularly described, according to said plat, as follows:

BEGINNING at an iron pin on the Eastern side of Summit Drive, joint front corner of Lots Nos. 5 and 6, and running thence with Summit Drive, N. 37-48 E. 58 feet to an iron pin, joint front corner of Lots Nos. 3 and 4; thence continuing with Summit Drive, N. 27-24 E. 28.5 feet to an iron pin, joint front corner of Lots Nos. 2 and 3; thence with the joint lines of said lots, S. 81-35 E. 132.4 feet to an iron pin; thence S. 8-25 W. 75 feet to an iron pin, joint rear corner of Lots Nos. 5 and 13; thence N. 81-35 W. 170.3 feet to the beginning corner.

Lot No. 3 was conveyed to the mortgagor by T. C. Stone, as Trustee by deed dated February 26, 1948, recorded in Volume 340 at Page 439, and Lots Nos. 4 and 5 were conveyed to the mortgagor by S. W. Jolly and Pearl Jolly by deed dated February 20, 1948, recorded in Volume 341 at Page 305.

Together with all and singular the improvements thereon and the rights, members, hereditaments, and appurtenances to the same belonging or in anywise appertaining; all the rents, issues, and profits thereof (provided, however, that the Mortgagor shall be entitled to collect and retain the said rents, issues, and profits until default hereunder); all fixtures now or hereafter attached to or used in connection with the premises herein described and in addition thereto the following described household appliances, which are and shall be deemed to be, fixtures and a part of the realty and are a portion of the security for the indebtedness herein mentioned;
