Whereas, I, the said Mildred K. Moore

Payable one year from date

with interest thereon from date

All that piece, parcel or lot of land in Grove Township, Greenville County, State of South Carolina, containing one and eighty nine-one hundredth (1 89/100) acres more or less, lying and situated in Grove Station School District, and being bounded by lands now or formerly owned by P.M.Huff-W.J.Grover-Wilmer Jacks and possibly others also by public road.
