SEND GREETING:

Whereas, **I**, the said **B.W.Wyrosdick**

in and by **My** certain **promissory** note in writing, of even date with these

Presents, **I am** well and truly indebted to **R.B.Gresham**

in the full and just sum of **Fifteen Hundred and NO/00**

to be paid

Payable one year from date

with interest thereon from **date**

at the rate of **6** per centum per annum, to be computed and paid **annually**

until paid in full: all interest not paid when due to bear

interest at same rate as principal: and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage: and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

sold and released, and by these Presents do grant, bargain, sell and release unto the said

R.B.Gresham, his heirs and assigns forever,

"All that certain piece, parcel, or tract of land, situated, lying and being in Grove Township, State and County aforesaid, on West side of U.S. Highway # 29, about one mile North of Piedmont, S.C.; adjoining lands of H.S. Collins and L.O. White, and according to a plat of same made by W.F. Adkins, surveyor, containing forty-seven and 13/100 acres, more or less and being the same tract of land conveyed to me by N.T. Richardson now living at Montverde, Florida, and more fully described in said deed and also more fully described in above referred to plat of same—neither deed nor plat having as yet been recorded but both are to be recorded at the same time of previous mortgage given to R.B. Gresham September, 28, 1943.
