to be paid on the first day of July 19 48 and thereafter said interest

and principal sum to be paid in installments as follows: Beginning on the first day of August 19 48, and on the first day of each month thereafter the

sum of \$ 45.45 - - - - to be applied on the interest and principal of said note, said payments to continue

up to and including the first day of June 19 68, and the balance

of said principal sum to be due and payable on the first day of July 19 68,
