NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the Eastern side of Maple Street, near the City of Greenville, being shown as lots # 7 and 8 of Block "B" on plat of Washington Heights, made by N. O. McDowell and Julian P. Moore in December 1944, which plat is recorded in the R.M.C. Office for Greenville County in Plat Book "M" at Page 107, and described as follows:

"BEGINNING at a stake on the Eastern side of Maple Street 200 feet North from Washington Loop at corner of lot # 9 and running thence with line of said lot, in an Easterly direction, 114 feet to a stake in line of lot 18; thence with lines of lots 18, 19 and 20, N. 28-03 W. 76.6 feet to an iron pin at corner of let # 6; thence with line of said lot in Westerly direction 118 feet to a stake on Maple Street; thence with the Eastern side of Maple Street 3. 27-24 E. 80 feet to the beginning corner.
