TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Robert E. Landers (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and lawfully indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C. (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Five Thousand and No/100 - - - - - DOLLARS (\$5000.00), with interest thereon from date at the rate of Five (5%) - - - per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagee in hand well and truly paid by the Mortgagee at and before the signing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, IN PARIS MOUNTAIN TOWNSHIP, adjoining Ellinadale Golf Course and described as follows:

"BEGINNING at an iron pin 548.7 feet North of the Property of Frances S. Tindal at the intersection of a county road and a new cut road and running thence N. 33-42 E. 282 feet to an iron pin, joint corner of said county road of the Ellis and Black tracts; thence N. 86-45 W. 335.8 feet to an iron pin; thence N. 71-47 W. 369 feet to an iron pin in the joint line of the Ellis and Black property; thence S. 0-30 E. 345 feet to an iron pin in said new road; thence with this new road, S. 78-11 E. 214 feet to an iron pin; thence N. 88-57 E. 142 feet to an iron pin; thence N. 84-46 E. 146 feet to the beginning corner."
