SEND GREETING:

Whereas, I the said Ibara Smith

in and by my certain Promissory note in writing, of even date with these presents, am well and truly indebted to Sara J. Thornton

in the full and just sum of Seven Hundred Fifty and No/100 (\$750.00) Dollars, to be paid one year after date

with interest thereon from date at the rate of Six (6%) per cent. per annum, to be computed and paid annually

until paid in full; all interest not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of ten (10%) per cent. of the amount due thereon, besides all costs and expenses of collection, to be added to the amount due on said note and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereunto had, will more fully appear.

Batson and Helen B. Dougherty recorded in the R.M.C. office for Greenville County in Plat Book 3 at Page 105, and when described together contains the following metes and bounds, to-wit:

BEGINNING at an iron pin on the East side of the Old Rutherford Road, at the joint front corner of lots # 10 and 11, and running thence with line of lot # 11, N. 86-10 E. 181.2 feet to an iron pin; thence with the rear line of lot # 12 and 13, N. 3-50 W. 100 feet to iron pin, corner of lot # 8; thence with line of lot # 8, S. 86-10 W. 212.8 feet to iron pin on Old Rutherford Road; thence with the Eastern side of Old Rutherford Road, 104.8 feet to the point of beginning.
