To All Whom These Presents May Concern: we, Delbert Brown and Lucile W.

SEND GREETING:

WHEREAS, we the said Delbert Brown and Lucile W. Brown, as in and by our certain promissory note in writing of even date with these Presents, are well and truly indebted unto the CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., in the full and just sum of Thirty-five hundred and no/100 - - (\$3500.00) Dollars, with interest from the date hereof at the rate of seven per cent (7 %) per annum, unpaid interest to bear interest at the same rate, to be repaid in installments of fifty-six and no/100 -

- - (\$ 56.00) dollars due and payable on the 5th day of each and every calendar month hereafter until the full principal sum, with interest and all costs, insurance, and expenses incurred in connection with said loan, has been paid, said monthly payments to be applied first to the payment of interest, and then to payment of principal, costs, expenses and insurance, if any, incurred; and said note further providing that if at any time any portion of the principal or interest due hereunder shall be past due and unpaid for a period of sixty (60) days, or upon failure to comply with any of the by-laws of said Association, or with any of the stipulations of this mortgage, the whole amount due under said note, shall at the option of the holder become immediately due and payable, and said note further providing for a reasonable attorney's fee besides all costs and expenses of collection, to be added to the amount due on said note, and collectible as a part thereof, if the same be placed with an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind.

KNOW ALL MEN BY THESE PRESENTS, That we the said mortgagors, in consideration of the said debt and sums of money aforesaid, and for the better securing the payment thereof to the said CITIZENS BUILDING & LOAN ASSOCIATION, Greer, S. C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00) Dollars to us the said mortgagors in hand well and truly paid by the said mortgagee, at and before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Butler Township, and having the following courses and distances, to-wit:-

Beginning at iron pin on the Pelham Road, joint corner of lots 2 and 3 of the property of the Atlantic Joint Stock Land Bank of Raleigh, N.C., and run thence S 7-30 E seven hundred twenty-five (725) feet to the corner of the Mission School lot; thence N 46-15 W four hundred eighteen and four-tenths (418.4) feet to the corner of lots 1 and 2; thence S 43-45 7 two hundred nine and two-tenths (209.2) feet to Roper Mountain Road; thence N 44-01 W six hundred sixty (660) feet to the intersection of Roper Mountain Road and Pelham Road; thence N 82-30 E eight hundred seventy-seven and seven-tenths (817.7) feet to the beginning corner, and is part of lots Nos. one and two (1 & 2), containing seven and fifty-six one-hundredths (7.56) acres, more or less, subject to easement of Duke Power Co. right-of-way: being lots 1 and 2 on plat recorded in Plat Book J, page 231; and this day conveyed to us by H.
