SEND GREETING:

Whereas, **I**, the said **Boyce E. Few**  
in and by **my** certain **promissory** note in writing, of even date with these  
Presents, **am** well and truly indebted to **W.C. Henson**  
in the full and just sum of **Two Thousand (\$2,000.00) Dollars**  
to be paid **One year from date hereof**

with interest thereon from **date**  
at the rate of **7** per centum per annum, to be computed and paid **annually**

until paid in full; all interest not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said **W.C. Henson and his heirs and assigns forever:**

**All of that parcel or tract of land situate and being in Chick Springs Township of Greenville County, South Carolina, about 1½ miles South from the Pleasant Grove Baptist Church and School, lying on the East side of the Gibbs Shoal Road, bounded by lands of T.M. Dillard, Belvin Clayton, Walker Elmore and possibly others, containing 45.44 Acres, more or less, and having the following courses and distances: BEGINNING at an iron pin on the Gibbs Shoal Road, the northwestern corner of the tract, and runs thence S. 87.30 E. 12.20 chains to a stone; thence S. 60.30 E. 8.80 chains to a large poplar; thence N. 55.30 E. 5.90 chains to a hickory, o/m/ (gone); thence S. 11.40 E. 16.50 chains to a**
