(\$ 3085.00), (evidenced by note(s) dated _____, 19____, hereby expressly made a part/interest) and to secure said advances, and any additional advances (not exceeding one-half of the amount above stated) that may subsequently be made to Borrower by Lender, to be evidenced by promissory notes, all renewals and extensions thereof, with interest until paid as provided in said note(s), and costs, including a reasonable attorney's fee of not less than ten per centum (10%) of the total amount due thereon and charges, as provided in said note(s) and herein, Borrower has granted, bargained, sold, conveyed and mortgaged, and by these presents does hereby grant, bargain, sell, convey and mortgage in fee simple unto Lender, its successors and assigns:

All that tract of land located in Austin Township, Greenville County, South Carolina, containing 18.5 acres, more or less, known as the Austin place, and bounded as follows:

North by the Locke Property; East by the Austin property; South by the right-of-way of the C&W Railway; and West by the Mulligan property, being more particularly described according to a survey by J. Mac Richardson, Registered L.S., dated Sept. 28, 1945 as follows:-

BEGINNING at an iron pin on the eastern right-of-way of the C&W Railway, said point being located 25 feet from the center line of the railroad; running thence along the railway right-of-way line S-17-38 E 943.5 feet to an iron pin on the right-of-way line; thence N 78-34 E, 204.7 feet to an iron pin; thence S 15-36 E/ 212.5 feet to an iron pin; thence N 80-13 E 330.7 feet to an iron pin in a ditch; thence N 4-11 W 287.2 feet to an iron pin in a ditch; thence N 0-25 W, 410.4 feet to an iron pin in a branch; thence with the branch as a line N 41-04 E 369.2 feet to an iron pin; thence N 18-15 W 462.0 feet to an iron pin; thence N 54-54 W 310.7 feet to an iron pin; thence S 23-44 W 440.3 feet to a leaning pine; thence S 69-57 W 546.2 feet to the beginning corner.

TOGETHER with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging or in any wise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said lands and premises unto Lender, its successors and assigns, with all the rights, privileges, members and appurtenances thereto belonging or in any wise appertaining.

UNDERSIGNED hereby binds himself, his heirs, executors, administrators and assigns to warrant and forever defend all and singular the said premises unto Lender, its successors and assigns, from and against Undersigned, his heirs, executors, administrators and assigns and all other persons whomsoever lawfully claiming or to claim the same or any part thereof.

PROVIDED ALWAYS, NEVERTHELESS, that if Borrower shall pay unto Lender, its successors or assigns, the aforesaid indebtedness and all interest and other sums secured by this or any other instrument executed by Borrower as security to the aforesaid indebtedness, and shall perform all of the terms, covenants, conditions, agreements, representations and obligations contained in a certain recorded Chattel Mortgage and/or Crop Lien, executed by Borrower to Lender, according to the true intent of said Chattel Mortgage and/or Crop Lien, all of the terms, covenants, conditions, agreements, representations and obligations of which are made a part hereof to the same extent as if set forth in extenso herein, then this instrument shall cease, determine and be null and void; otherwise it shall remain in full force and effect.
