TO ALL WHOM THESE PRESENTS MAY CONCERN:

We, Johnson B. Horton, Jr. and (hereinafter referred to as Mortgagor) and Violet J. Horton (hereinafter referred to as Mortgagee) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Fifty-Nine Hundred Twelve and 4/100- - - - - DOLLARS (\$5912.04), with interest thereon from date at the rate of Five & One-Half per centum per annum, said principal and interest to be repaid as therein stated, and

"All <sup>those</sup> ~~that~~ certain piece, <sup>s</sup>parcels or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the Western side of Westview Avenue, in the City of Greenville, being shown as lots # 24 and 25 on Plat of Section A of Parkvale, recorded in Plat Book "K" at Page 52, and described as follows:

"BEGINNING at a stake on the Western side of Westview Avenue, at corner of lot # 23, and running thence with line of said lot, N. 89 W. 362 feet to a stake on a branch; thence with said branch in a Northerly direction 140 feet, more or less, to a stake at corner of lot # 26; thence with the line of said lot, S. 89-00 E. 364 feet to a stake on Westview Avenue; thence with the Western side of Westview Avenue, S. 12-00 W. 140 feet to the beginning corner."

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
