all that tract or lot of land in Paris Mountain Township, Greenville County, State of South Carolina, containing 8.66 acres, and known and designated on plat of property of Mildred Hill, as Lots Nos. 2 and 4, situate about 9 miles from the City of Greenville on the Little Texas Road, and having, according to said plat, the following courses and distances:
