All that certain piece, parcel or lot of land situate, lying and being in the County and State aforesaid, on the North side of Perry Avenue just outside the corporate limits of the City of Greenville, and having the following metes and bounds, to-wit:

BEGINNING at a stake on the North side of Perry Avenue, 100 feet from the Southwest corner of lot sold to W. S.
