RECORDING

, to be paid One Hundred Dollars (\$100.00) six months  
after date and Two Hundred Dollars (\$200.00) each succeeding six  
months period until paid

, with interest thereon from date  
at the rate of six per centum per annum, to be computed and paid semi-annually

until paid in full; all interest not paid when due to bear  
interest at same rate as principal; and if any portion of principal or interest be at any time past due  
and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the  
holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its matur-  
ity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should  
be deemed by the holder thereof necessary for the protection of his interests to place and the holder  
should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then

All that piece, parcel or lot of land in Greenville Township, Greenville  
County, State of South Carolina, being known and designated as Lot 19B  
in Section "H" of Woodville Heights, as shown on plat made by W. J.  
Riddle, December, 1940, and recorded in Plat Book "L", pages 14 and 15  
in R. M. C. Office for Greenville County, S. C. and being more  
particularly described as follows:

BEGINNING at an iron pin on the branch at corners of Lots Nos. 19-A and  
19-B, and the rear line of Lot No. 19; thence running S. 53-50 E. 106  
feet; thence sunning S. 35-05 W. 100 feet to an iron pin at the joint  
corners of Lots Nos. 19-B and 13-A; thence running S. 43 E. 120 feet  
to an iron pin at the joing corners of Lots Nos. 19 and 13, also 19-B
