in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Mary G. Traxler and David G. Traxler, sole directors and liquidating trustees of Traxler Real Estate Company, a Corporation in liquidation,

all that tract or lot of land in

Greenville Township, Greenville County, State of South Carolina, near the City of Greenville, South Carolina, lying and being situate on the Northwest side of Round Knob Street, being known and designated as Lot # 41, Sterling College Park Addition, according to plat of said sub-division prepared by Dalton & Neves in June 1940, as recorded in the R.M.C. Office, Greenville, South Carolina, in Plat Book "I" on Page 171 and having, according to said Plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the Northwest side of Round Knob Street at joint front corner of Lots # 41 and # 42, said pin being 250 feet Southwest of iron pin in the Northwest corner of the intersection of Round Knob Street with Valentine Street; thence N. 27-0 W. 117.2 feet to an iron pin at joint corner of Lots # 41 and # 42 on the South side of Maloy Street; thence S. 56-27 W. 50.2 feet to an iron pin at joint rear corner of Lots # 40 and # 41; thence S. 27-0 E. 107.9 feet to an iron pin at joint front corner of Lots # 40 and # 41 on the Northwest side of Round Knob Street; thence N. 67-04 E. 50 feet along said Street to an iron pin at joint front corner of Lots # 41 and # 42, the point of beginning.
