"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and in Greenville Township on the Southeast corner of Third Avenue and Sixth Street of Judson Mill Village, being shown as Lot #19 on Plat of Section 3 of Judson Mill Village, made by Dalton and Neves, Engineers, in March, 1940, recorded in Plat Book K, page 42, and described as follows:
